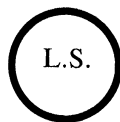
I, MARY COUGHLAN, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Directive 2008/2/EC of the European Parliament and of the Council¹, hereby make the following Regulations:

1. These Regulations may be cited as the European Communities (Agricultural or Forestry Tractors Type Approval) (Amendment) Regulations 2008.

2. The European Communities (Agricultural or Forestry Tractors Type Approval) Regulations 2005 (S.I. No. 69 of 2005) are amended, in Regulation 2(1), by substituting for the definition of “the Directive” (inserted by the European Communities (Agricultural or Forestry Tractors Type Approval) (Amendment) Regulations 2007 (S.I. No. 162 of 2007)) the following—

“ ‘Directive’ means Directive 2003/37/EC of the European Parliament and of the Council of 26 May 2003² as amended by Commission Directive 2005/13/EC of 21 February 2005³, Commission Directive 2005/67/EC of 18 October 2005⁴, Commission Directive 2006/26/EC of 2 March 2006⁵, Commission Directive 2006/96/EC of 20 November 2006⁶ and Directive 2008/2/EC of the European Parliament and of the Council.”

3. The European Communities (Agricultural or Forestry Tractors Type Approval) (Amendment) Regulations 2007 (S.I. No. 162 of 2007) are revoked.
