VARIATION OF DAYS AND HOURS (BANAGHER AND  
BALLINASLOE AND BIRR AND EYRECOURT) ORDER, 2008

The Courts Service, in exercise of the powers conferred on it by section 26 of the Courts of Justice Act, 1953 (No. 32 of 1953), as amended by section 43 of the Courts (Supplemental Provisions) Act, 1961 (No. 39 of 1961), section 16 of the Courts Act, 1971 (No. 36 of 1971) and section 29 of the Courts Service Act, 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. (a) This Order may be cited as the District Court Districts and Areas (Amendment) and Variation of Days and Hours (Banagher and Ballinasloe and Birr and Eyrecourt) Order, 2008.

(b) This Order shall come into operation on 3rd July, 2008.

2. The First Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

(a) The deletion at reference 201 of the matter in columns (2), (3), (4) and (5)

(b) The deletion at reference 87 of the matter in columns (2), (3), (4) and (5)

(c) The substitution at reference 202 for the matter in column's (4) and (5) of the following:

“ Birr —  
Second Friday in every month at  
10.30 a.m.  
Fourth Friday in February, April,  
June, October and December at  
10.30 a.m.

The area comprising—  
(a) the District Electoral Divisions  
of Ballincor, Banagher, Birr Rural,  
Birr Urban, Dromoyle, Eglish,  
Kilcolman, Killyon, Kinnitty,  
Knockbarron, Letter, Lusmagh,  
Mounterin, Seirkieran, Shannon  
Harbour and Tulla in the county of  
Offaly, and

(b) the District Electoral Divisions  
of Carrig, Clohaskin, Graigue,  
Lorrha Éast, Rathcabban,  
Redwood and Riverstown in the  
county of Tipperary (North  
Riding).”

and

- (d) The substitution at reference 81 for the matter in columns (4) and (5) of the following:

First and Third Wednesday, First

every month at 10.30 a.m.

(a) the Electoral Divisions of  
Abbeygormacan, Ahascragh,  
Annagh, Aughrim (Ballinasloe),  
Ballinasloe Rural, Ballinasloe  
Urban, Ballymacward, Ballynakill  
(Mount Bellew), Caltra,  
Cappalusk, Castleblakeney,  
Castlefrench, Clonbrock, Clonfert,  
Clonkeen (Mount Bellew),  
Clontuskert, Colmanstown,  
Cooloo, Derrew, Derryglassaun,  
Eyrecourt, Kellysgrove, Kilconnell,  
Killallaghtan, Killian, Killeroran,  
Killoran, Killure, Kilmacshane,  
Kilquain, Kiltormer, Kylemore,  
Laurencetown, Lismanny, Meelick,  
Mount Bellew, Mounthazel,  
Oatfield and Taghboy in the  
county of Galway, and

(b) the Electoral Divisions of  
Ballydangan, Caltragh,  
Carrowreagh, Cloonburren,  
Creagh, Culliagh, Dysart, Kilcar,  
Lismaha, Moore, Taghboy,  
Taghmaconnell and Turrock in the  
county of Roscommon.”

3. The Second Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

- (a) The deletion at reference 171 of the matter in columns (2), (3), (4) and (5)
- (b) The deletion at reference 76 of the matter in columns (2), (3), (4) and (5)
- (c) The substitution at reference 172 for the matter in column (5) of the following:

“ Birr—  
Second Friday in every month at 10.30 a.m.  
Fourth Friday in February, April, June, October and December at 10.30 a.m.

The area comprising—  
(a) the District Electoral Divisions of Ballincor, Banagher, Birr Rural, Birr Urban, Dromoyle, Eglish, Kilcolman, Killyon, Kinnitty, Knockbarron, Letter, Lusmagh, Mounterin, Seirkieran, Shannon Harbour and Tulla in the county of Offaly, and

(b) the District Electoral Divisions of Carrig, Clohaskin, Graigue, Lorrha East, Rathcabban, Redwood and Riverstown in the county of Tipperary (North Riding).”

and

- (d) The substitution at reference 71 for the matter in column (5) of the following:

“ Ballinasloe—  
First and Third Wednesday, First Thursday and Fourth Tuesday in every month at 10.30 a.m.

The area comprising—  
(a) the Electoral Divisions of Abbeygormacan, Ahascragh, Annagh, Aughrim (Ballinasloe), Ballinasloe Rural, Ballinasloe Urban, Ballymacward, Ballynakill (Mount Bellew), Caltra, Cappalusk, Castleblakeney, Castlefrench, Clonbrock, Clonfert, Clonkeen (Mount Bellew), Clontuskert, Colmanstown, Cooloo, Derrew, Derryglassaun, Eyrecourt, Kellysgrove, Kilconnell, Killallaghtan, Killian, Killeroran, Killoran, Killure, Kilmacshane, Kilquain, Kiltormer, Kylemore, Laurencetown, Lismanny, Meelick, Mount Bellew, Mounthazel, Oatfield and Taghboy in the county of Galway, and

(b) the Electoral Divisions of Ballydangan, Caltragh, Carrowreagh, Cloonburren, Creagh, Culliagh, Dysart, Kilcar, Lismaha, Moore, Taghboy, Taghmaconnell and Turrock in the county of Roscommon.

4. The Schedule to the District Court Areas (Amendment) Order, 1970 (S.I. No. 161 of 1970), is hereby amended at reference number 2 in column (4) by the deletion of “Banagher”, “Eyrecourt”, “201” and “87”.

5. Business transacted in the District Court that is initiated and not completed before commencement of this Order shall be continued and completed as if this Order had been in force at the time at which such business had been initiated.
