(COROFIN AND KILDYSART AND ENNIS, ENNISTYMON AND  
KILRUSH) AND VARIATION OF DAYS (ENNIS AND ENNISTYMON)  
ORDER, 2008.

The Courts Service, in exercise of the powers conferred on it by section 26 of the Courts of Justice Act, 1953 (No. 32 of 1953), as amended by section 43 of the Courts (Supplemental Provisions) Act, 1961 (No. 39 of 1961), section 16 of the Courts Act, 1971 (No. 36 of 1971) and section 29 of the Courts Service Act, 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. (a) This Order may be cited as the District Court Districts and Areas (Amendment) (Corofin and Kildysart and Ennis, Ennistymon and Kilrush) and Variation of Days (Ennis and Ennistymon) Order, 2008.

(b) This Order shall come into operation on 1st March, 2008.

2. The First Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

(a) The deletion at reference 15 of the matter in columns (2), (3), (4) and (5)

(b) The deletion at reference 18 of the matter in columns (2), (3), (4) and (5)

(c) The substitution at reference 16 for the matter in column (5) of the following:

“The area comprising—

the Electoral Divisions of Ballyeighter, Ballynacally, Boston, Clareabbey, Clondagad, Clooney (Tulla), Corofin, Crusheen, Doora, Dysert, Ennis Rural, Ennis No. 1 Urban, Ennis No. 2 Urban, Ennis No. 3 Urban, Ennis No. 4 Urban, Furroor, Glenmore, Glenroe, Kilchreest, Kilcloher, Killadysert, Killanniv, Killinaboy, Killone, Kilnamona, Kilraghtis, Kinturk, Liscasey Lisheen, Muckanagh, Newmarket, Quin, Ruan, Spancelhill, Templemaley, Tomfinlough and Urlan in the county of Clare.”

and

(d) The substitution at reference 17 for the matter in column (5) of the following:

“Iris Oifigiúil” of 29th February, 2008.*

“The area comprising—

the Electoral Divisions of Ballagh, Ballyea, Ballysteen, Carran, Castletown, Clooney (Ennistimon), Ennistimon, Kilfenora, Killaspuglonane, Kilshanny, Kiltoraght, Liscannor, Magherareagh, Moy, Noughaval, Rath, and Smithstown in the county of Clare.”

and

- (e) The substitution at reference 21 for the matter in column (5) of the following:

“The area comprising—

The Electoral Divisions of Clooncoorha, Coolmeen, Cooraclare, Drumellihiy, Kilfiddane, Killimer, Kilmihil, Killofin, Kilmurry (Killadysert), Kilrush Rural, Kilrush Urban, Knock, Rinealon and Tullycreen in the county of Clare.”

3. The First Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

- (a) the substitution at reference number 17 for the matter in column (4) of the following:

“Ennistymon—

First Wednesday in January, February, March, April, May, June, July, September, October, November and December at 11.00 a.m.”

4. The Second Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

- (a) the substitution at reference number 16 for the matter in column (4) of the following:

“Ennistymon—

First Wednesday in January, February, March, April, May, June, July, September, October, November and December at 11.00 a.m.”

5. The Second Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

- (a.) the substitution at reference number 15 for the matter in column (4) of the following:

“First Tuesday and third Tuesday at 11.00 a.m.  
Fourth Thursday in each month at 11.00 a.m.”

6. Business transacted in the District Court that is initiated and not completed before commencement of this Order shall be continued and completed as if this Order had been in force at the time at which such business had been initiated.

*(This note does not form part of the instrument and is not a legal interpretation.)*

This order provides for—

- (a) The amalgamation of the Electoral Divisions of the District Court Area of Corofin into the District Court Areas of Ennis and Ennistymon.
- (b) The amalgamation of the Electoral Divisions of the District Court Area of Kildysart into the District Court Areas of Ennis and Kilrush.
- (c) Variation of Days in Ennis District Court, Family Law to be heard on First Tuesday and Third Tuesday.
- (d) Variation of Days in Ennistymon, sitting first Wednesday every month except the month of August.
