LOCAL ELECTIONS (FORMS) (AMENDMENT) REGULATIONS 2009

The Minister for the Environment, Heritage and Local Government, in exercise of the powers conferred on him by section 3 of the Local Elections (Disclosure of Donations and Expenditure) Act 1999, as amended, hereby makes the following Regulations:

- 1. These Regulations may be cited as the Local Elections (Forms) (Amendment) Regulations 2009.
- 2. The Local Elections (Forms) Regulations 2009 (S.I. No. 116 of 2009) are hereby amended by the substitution of the following Part for Part 9 of Form 2 in the Schedule to the said Regulations:

"9. Statutory Declaration

THE FOLLOWING STATUTORY DECLARATION MUST BE MADE BY THE NATIONAL AGENT/DESIGNATED PERSON OR THIRD PARTY (delete as appropriate).

Signed [national agent/designated person/third party]

who is personally known to me,

or

who is identified to me by who is personally known to me

or



A person who knowingly makes a false or misleading statutory declaration is liable on conviction to a fine not exceeding €3,000 or imprisonment for a term not exceeding six months or both.".

EXPLANATORY NOTE

(This note is not part of the Instrument and does not purport to be a legal interpretation).

These Regulations provide for the amendment of the Local Elections (Forms) Regulations 2009 by the substitution of a revised Part for Part 9 of Form 2 in the Schedule to the said Regulations. Form 2 is the prescribed form to be used by national agents, designated persons and third parties for furnishing statements of donations and election expenses at local elections in accordance with section 13 of the Local Elections (Disclosure of Donations and Expenditure) Act 1999.
