I, MARY COUGHLAN, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), and for the purpose of giving effect to Commission Decision 2007/99/EC of 14 February 2007<sup>1</sup>, hereby make the following regulations—

1. These Regulations may be cited as the European Communities (Avian Influenza) (Protection Measures Relating to Third Countries) (Amendment) Regulations 2007.

2. The European Communities (Avian Influenza) (Protection Measures Relating to Third Countries) Regulations 2006 (S.I. No. 554 of 2006) are amended by—

(a) the substitution, for the definition of “Commission Decision”, in Regulation 2(1), of—

“ ‘Commission Decision’ means Commission Decision 2005/692/EC of 6 October 2005<sup>2</sup> as amended by Commission Decision 2006/521/EC of 25 July 2006<sup>3</sup> and Commission Decision 2007/99/EC of 14 February 2007;”.

(b) the insertion, in Regulation 3 (1), of “, South Korea” before “or Malaysia”.
