BETTING ACT (REVENUE FORMS) REGULATIONS 2007

I, BRIAN COWEN, Minister for Finance, in exercise of the powers conferred on me by section 35(2) of the Betting Act 1931 (No. 27 of 1931), hereby make the following regulations:

1. (1) These Regulations may be cited as the Betting Act (Revenue Forms) Regulations 2007.

(2) The Betting Act (Revenue Forms) Regulations 1931 to 1999 and these Regulations may be cited together as the Betting Act (Revenue Forms) Regulations 1931 to 2007.

2. The Schedule to the Betting Act (Revenue Forms) Regulations 1931 (S.R. & O. No. 8 of 1931) is amended by substituting for the forms set out in that Schedule, the forms set out in the Schedule to these Regulations.

- 2) a remittance for the proper amount of the excise duty payable in respect of the licence for which the application is being made.



- (a) that it may reach that office not more than 21 days after the issue of the certificate of suitability of premises issued in respect of the premises to which the application relates, and
- (b) in the case of an application for renewal of registration, that it may reach that office not more than 14 days before the expiration of the registration or the last renewal of the registration of such premises.

On the making of an application for registration or renewal of registration of premises in the register of bookmaking offices this form must be accompanied by—

- (1) a certificate of suitability of the premises to which the application relates;
- (2) a remittance for the proper amount of the excise duty payable in respect of the registration or renewal of registration of the premises in respect of which the application is made.

Unless and until removed from the register under or by virtue of the Betting Act 1931, or the Finance Act 2002, any premises registered in the register of bookmaking offices shall continue to be so registered until midnight on the 30 November next after the registration thereof and shall then (unless the registration has been renewed under the Betting Act 1931) be removed from the said register.

Registered premises shall not be opened or kept open for the transaction of business at any time on any Christmas Day, Good Friday or Easter Sunday or on any other day—

- at any time before 7 o'clock in the morning and after 6.30 o'clock in the evening during the period from 1 September in any year to 31 March in the following year, and
- at any time before 7 o'clock in the morning and after 10 o'clock in the evening—
 - (a) during the period from 1 April in any year to 31 August in that year, and
 - (b) during the period from 1 September in any year to 31 March in the following year on any day on which a race-meeting at an authorised racecourse is taking place on or after 6.30 o'clock in the evening on that day.
