EUROPEAN COMMUNITIES (UNDESIRABLE SUBSTANCES IN FEEDINGSTUFFS) (AMENDMENT) REGULATIONS 2007

I, MARY COUGHLAN, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) for the purpose of giving effect to Commission Directive No. 2006/77/EC of 29 September 2006¹, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Undesirable Substances in Feedingstuffs) (Amendment) Regulations 2007.

2. Regulation 2(1) of the European Communities (Undesirable Substances in Feedingstuffs) Regulations 2003 (S.I. No. 317 of 2003) is amended by substituting for the definition of “Directive” the following—

“‘Directive’ means Directive No. 2002/32/EC of the European Parliament and of the Council of 7 May 2002² as amended by Commission Directive No. 2003/57/EC of 17 June 2003³; Commission Directive No. 2003/100/EC of 31 October 2003⁴; Commission Directive 2005/8/EC of 27 January 2005⁵; (from 26 December 2006) Commission Directive 2005/86/EC of 5 December 2005⁶; Commission Directive 2005/87/EC of 5 December 2005⁷; Commission Directive 2006/13/EC of 3 February 2006⁸ and Commission Directive 2006/77/EC of 29 September 2006.”.

These Regulations give effect to Commission Directive 2006/77/EC of 29 September 2006 which amends the maximum levels set for organochlorine compounds in animal feed in Annex I to Directive 2002/32/EC of the European Parliament and of the Council on undesirable substances in animal feed.
