DISTRICT COURT DISTRICTS AND AREAS (AMENDMENT) AND
VARIATION OF DAYS AND HOURS (DOIRE AN FHÉICH, AN
SPIDÉAL, GALWAY, BALLYCONNELL AND SWANLINBAR AND
CAVAN) ORDER 2013.

The Courts Service, in exercise of the powers conferred on it by section 26 of the Courts of Justice Act 1953 (No. 32 of 1953), as amended by section 43 of the Courts (Supplemental Provisions) Act 1961 (No. 39 of 1961), section 16 of the Courts Act 1971 (No. 36 of 1971) and section 29 of the Courts Service Act 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. (a) This Order may be cited as the District Court Districts and Areas (Amendment) and Variation of Days and Hours (Doire an Fhéich, An Spidéal, Galway, Ballyconnell and Swanlinbar and Cavan) Order 2013.
- (b) This Order shall come into operation on 1st September, 2013

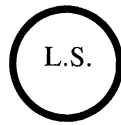

This order provides for—

- (a) The amalgamation of the Electoral Divisions of the District Court Area of an Spidéal into the District Court Area of Doire an Fheich.
- (b) The amalgamation of the Electoral Divisions of the District Court Area of Ballyconnell and Swanlinbar into the District Court Area of Cavan.
- (c) The variation of Days and Hours at Doire an Fhéich and Galway and Cavan.
