BOVINE VIRAL DIARRHOEA (AMENDMENT) REGULATIONS 2014

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 36 of the Animal Health and Welfare Act 2013 (No. 15 of 2013), hereby make the following regulations:

1. These Regulations may be cited as the Bovine Viral Diarrhoea (Amendment) Regulations 2014.

2. The Bovine Viral Diarrhoea Regulations 2014 are amended in the Schedule by—
