SEA-FISHERIES (CONTROL ON FISHING FOR RAZOR CLAMS)  
(REVOCATION) REGULATIONS 2014

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 and 15 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea-Fisheries, Fore-shore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), hereby make the following regulations:

1. These Regulations may be cited as the Sea-Fisheries (Control on fishing for razor clams) (Revocation) Regulations 2014.
2. The following are revoked:
  - (a) Sea-fisheries (Control on fishing for razor clams in Rosslare Harbour) Regulations 2010 (S.I. No. 310 of 2010);
  - (b) Sea-fisheries (Control on fishing for razor clams in Rosslare Harbour) (Amendment) Regulations 2010 (S.I. No. 437 of 2010);
  - (c) Sea-fisheries (Control on fishing for razor clams in Cahore) Regulations 2011 (S.I. No. 425 of 2011).
