I, SIMON HARRIS, Minister for Health, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Implementing Regulation (EU) 2017/2298 of 12 December 2017¹, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) Regulations 2018.

2. Regulation 2(1) of the European Communities (Official Controls on the Import of Food of Non-Animal Origin) Regulations 2010 (S.I. No. 391 of 2010) is amended by substituting for the definition of “EC Regulation 669/2009” (inserted by the European Communities (Official Controls on the Import of Food of Non-Animal Origin) Regulations 2017 (S.I. No. 319 of 2017)) the following:

“‘EC Regulation 669/2009’ means Commission Regulation (EC) No. 669/2009 of 24 July 2009², as amended by Commission Regulation (EU) No. 212/2010 of 12 March 2010³, Commission Implementing Regulation (EU) No. 323/2014 of 28 March 2014⁴, Commission Implementing Regulation (EU) No. 718/2014 of 27 June 2014⁵, Commission Implementing Regulation (EU) 2016/1024 of 24 June 2016⁶ and Commission Implementing Regulation (EU) 2017/2298 of 12 December 2017¹;”.

EXPLANATORY NOTE

These Regulations give effect to Commission Implementing Regulation (EU) 2017/2298 of 12 December 2017 amending Regulation (EC) No. 669/2009 as regards the increased level of official controls on imports of certain food of non-animal origin.

These Regulations amend the European Communities (Official Controls on the Import of Food of Non-Animal Origin) Regulations 2010 (S.I. No. 391 of 2010) in the manner specified in these Regulations.

These Regulations revoke the European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) Regulations 2017 (S.I. No. 319 of 2017).

These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) Regulations 2018.
