## HEALTH INSURANCE ACT 1994 (SECTION 11E(3)) (AMENDMENT) REGULATIONS 2025

The Health Insurance Authority pursuant to section 11E(3) of the Health Insurance Act 1994 (No. 16 of 1994) (inserted by section 15 of the Health Insurance (Amendment) Act 2012) (No. 45 of 2012) and section 8 of the Health Insurance (Amendment) Act 2013 (No. 48 of 2013)), hereby makes the following Regulations:

#### Citation and commencement

- 1. (1) These Regulations may be cited as the Health Insurance Act 1994 (Section 11E(3)) (Amendment) Regulations 2025.
- (2) These Regulations shall come into operation on the 22nd day of October 2025.

  - (e) by the deletion of "168" in column (1), "Aviva Health Insurance Ireland Ltd" in column (2), "We Plan Level 1 with Day to day A" in column (3), and "31 March 2013" in column (4) of the Schedule.
