EUROPEAN COMMUNITIES (PHYTOSANITARY MEASURES) (SUDDEN OAK DEATH) (AMENDMENT) REGULATIONS 2007

- I, MARY COUGHLAN, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Decision 2007/201/EC of 27 March 2007¹, hereby make the following Regulations—
- 1. These Regulations may be cited as the European Communities (Phytosanitary Measures) (Sudden Oak Death) (Amendment) Regulations 2007.
- 2. The European Communities (Phytosanitary Measures) Regulations 2004 (S.I. No. 578 of 2004) are amended in Regulation 2(1) by substituting for the definition of 'Commission Decision' the following—
 - "'Commission Decision' means Commission Decision No. 2002/757/EC of 19 September 2002 as amended by Commission Decision No. 2004/426/EC of 29 April 2004 and Commission Decision No. 2007/201/EC of 27 March 2007;".
