

# EUROPEAN COMMUNITIES (CARRIAGE OF DANGEROUS GOODS BY ROAD ACT 1998) (AMENDMENT) REGULATIONS 2010

- I, BATT O'KEEFFE, Minister for Enterprise, Trade and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Directive 2008/68/EC of the European Parliament and of the Council of 24 September 2008 on the inland transport of dangerous goods<sup>1</sup>, as amended by Commission Decision 2010/187/EU of 25 March 2010<sup>2</sup>, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Carriage of Dangerous Goods by Road Act 1998) (Amendment) Regulations 2010.
- 2. Section 1 of the Carriage of Dangerous Goods by Road Act 1998 (No. 43 of 1998) is amended by—
  - (a) substituting the following definition for the definition of "the Annexes":
    - " 'the Annexes' means Annexes A and B to the ADR referred to in Annex I to Directive 2008/68/EC of the European Parliament and of the Council of 24 September 2008<sup>1</sup>, as amended by Commission Decision 2010/187/EU of 25 March 2010<sup>2</sup>;

and

- (b) substituting the following definition for the definition of "the Directives":
  - "the Directives' means Council Directive 95/50/EC of 6 October 1995<sup>3</sup> and Directive 2008/68/EC of the European Parliament and of the Council of 24 September 2008<sup>1</sup>, as amended by Commission Decision 2010/187/EU of 25 March 2010<sup>2</sup>;

### **EXPLANATORY NOTE**

(This note is not part of the Instrument and does not purport to be a legal interpretation)

These Regulations amend the Carriage of Dangerous Goods by Road Act 1998 in order to allow for the transposition of Directive 2008/68/EC of the European Parliament and of the Council of 24 September 2008 on the inland transport of dangerous goods as amended by Commission Decision 2010/187/EU of 25 March 2010 by means of Regulations made under that Act.
