## EUROPEAN COMMUNITIES (TRANSMISSIBLE SPONGIFORM ENCEPHALOPATHIES AND ANIMAL BY-PRODUCTS) (AMENDMENT) REGULATIONS 2011

I, SIMON COVENEY, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Regulation (EC) No. 1069/2009 of the European Parliament and of the Council of 21 October 2009<sup>1</sup> and Commission Regulation (EU) No. 142/2011 of 25 February 2011<sup>2</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Transmissible Spongiform Encephalopathies and Animal By-products) (Amendment) Regulations 2011.

2. A reference in the European Communities (Transmissible Spongiform Encephalopathies and Animal By-products) Regulations 2008 (S.I. No. 252 of 2008) or in an instrument issued under those Regulations—

- (a) to a provision in Regulation (EC) No. 1774/2002 of the European Parliament and of the Council of 3 October 2002<sup>3</sup> is to be read in accordance with the correlation table in the Annex to Regulation (EC) No. 1069/2009 of the European Parliament and of the Council of 21 October 2009, or
- (b) to an enactment repealed by Article 35 of Commission Regulation (EU) No. 142/2011 of 25 February 2011 is construed as a reference to the relevant article of that Regulation.
