I, ALAN SHATTER, Minister for Justice and Equality, in exercise of the powers conferred on me by section 29(2) of the Courts Service Act 1998 (No. 8 of 1998) (as adapted by the Justice and Law Reform (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. 1. (1) This Order may be cited as the Courts Service Act 1998 (Section 29(2)) Order 2011.

(2) This Order comes into operation on 1 November 2011.
