## EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING VEGETABLE SPECIES) (AMENDMENT) REGULATIONS 2011

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive 2011/68/EC of 1 July 2011<sup>1</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining Vegetable Species) (Amendment) Regulations 2011.

2. The European Communities (Minimum Conditions for Examining of Vegetable Species) Regulations 2004 (S.I. No. 121 of 2004) are amended by substituting in Regulation 2 the definition of "Directive" for the following—

"'Directive' means Commission Directive 2003/91/EC of 6 October 2003<sup>2</sup> as amended by Commission Implementing Directive 2011/68/EU of 1 July 2011.".

3. The European Communities (Minimum Conditions for Examining Vegetable and Plant Species) (Amendment) Regulations 2009 (S.I. No. 530 of 2010) is revoked.
