# SEA-FISHERIES (TECHNICAL MEASURES) (AMENDMENT) REGULATIONS 2012

- I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 3, 12 and 14 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea Fisheries, Foreshore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), for the purpose of giving full effect to Commission Regulation (EU) No 161/2012 of 23 February 2012<sup>1</sup> hereby make the following regulations:
- 1. These Regulations may be cited as the Sea-Fisheries (Technical Measures) (Amendment) Regulations 2012.
- 2. The Sea-Fisheries (Technical Measures) Regulations 2011 (S.I. No. 481 of 2011) are amended by the substitution, for Regulation 2(1) of—
  - "2. (1) In these Regulations "Technical Measures Regulation" means those provisions of Annex III to Council Regulation (EC) No. 43/2009 of 16 January 2009<sup>2</sup> as amended by Council Regulation (EC) No 753/2009 of 27 July 2009<sup>3</sup> and Council Regulation (EC) No. 1288/2009 of 27 November 2009<sup>4</sup> (which is amended by Regulation (EU) No. 579/2011 of the European Parliament and of the Council of 8 June 2011<sup>5</sup>) and Commission Regulation (EU) No 161/2012 of 23 February 2012."
  - 3. These Regulations shall remain in force until the 25 August 2012.
