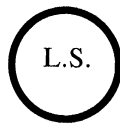

I, JAMES REILLY, Minister for Health, in exercise of the powers conferred on me by section 26(3) of the Health and Social Care Professionals Act 2005 (No. 27 of 2005) (as adapted by the Health and Children (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 219 of 2011)), hereby order as follows:

1. This Order may be cited as the Dietitians Registration Board (Establishment Day) Order 2012.
2. The 1st day of November 2012 is appointed as the establishment day of the Dietitians Registration Board.

EXPLANATORY NOTE

(This note is not part of the Instrument and does not purport to be a legal interpretation).

The effect of this Order is to establish, under the Health and Social Care Professionals Act 2005, a body known as the Dietitians Registration Board, which will register Dietitians, thus protecting the public by fostering high standards of professional conduct and professional education, training and competence among registrants of the dietetic profession.
