EUROPEAN UNION (CROSS-BORDER MERGERS)(INTERCONNECTION OF BUSINESS REGISTERS) REGULATIONS 2014

- I, RICHARD BRUTON, Minister for Jobs, Enterprise and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Directive No. 2012/17/EU of the European Parliament and of the Council of 13 June 2012¹ hereby make the following regulations:
- 1. These Regulations may be cited as the European Union (Cross-Border Mergers) (Interconnection of Business Registers) Regulations 2014.
- 2. The European Communities (Cross-Border Mergers) Regulations 2008 (S.I. No. 157 of 2008) are amended—
 - (a) in Regulation 2(1) by—
 - (i) the substitution for the definition of "Directive" of the following:
 - "'Directive' means Directive No. 2005/56/EC of the European Parliament and of the Council of 26 October 2005² on cross-border mergers of limited liability companies as amended by Directive No. 2009/109/EC of the European Parliament and of the Council of 16 September 2009³ and Directive No. 2012/17/EU of the European Parliament and of the Council of 13 June 2012⁴;", and
 - (ii) the insertion of the following:
 - "'Directive No. 2009/101/EC' means Directive No. 2009/101/EC of the European Parliament and of the Council of 16 September 2009⁵ as amended by Directive No. 2012/17/EU of the European Parliament and of the Council of 13 June 2012⁶:

'interconnection system' means the system of interconnection of central, commercial and companies registers established in accordance with Article 4a(2) of Directive No. 2009/101/EC;", and

- (b) in Regulation 18 by the insertion of the following paragraph after paragraph (1):
 - "(1A) On and from the date of the establishment of the interconnection system, the Registrar shall give the notice referred to in subparagraph (a) of paragraph (1) through the interconnection system.".
