- I, FRANCES FITZGERALD, Minister for Justice and Equality, in exercise of the powers conferred on me by sections 5, 162 and 169 of the Criminal Justice (Forensic Evidence and DNA Database System) Act 2014 (No. 11 of 2014), hereby make the following regulations:
- 1. These Regulations may be cited as the Criminal Justice (Forensic Evidence and DNA Database System) Act 2014 (Certificates) Regulations 2015.
- 2. In these Regulations "Act of 2014" means the Criminal Justice (Forensic Evidence and DNA Database System) Act 2014 (No. 11 of 2014).
- 3. The form set out in Schedule 1 is prescribed as the form of a certificate under section 162 of the Act of 2014.
- 4. The form set out in Schedule 2 is prescribed as the form of a certificate under section 169 of the Act of 2014.

Section 162 certificate for the purpose of evidence in relation to an authorisation given by a member of the Garda Síochána in relation to the taking of samples under Part 2 of the Act, other than section 11.
