## EUROPEAN COMMUNITIES (OFFICIAL CONTROLS ON THE IMPORT OF FOOD OF NON-ANIMAL ORIGIN FOR PESTICIDE RESIDUES) (AMENDMENT) (NO.2) REGULATIONS 2016.

- I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Regulation (EU) 2016/166 of 8 February 2016<sup>1</sup> and Commission Implementing Regulation (EU) 2016/443 of 23 March 2016<sup>2</sup> hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) (Amendment) (No.2) Regulations 2016.
- 2. The European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) Regulations 2011 (S.I. No. 426 of 2011) are amended by substituting in Regulation 2(1) for the definition of "Commission Regulation 669/2009" the following—
  - "'Commission Regulation 669/2009' means Commission Regulation (EC) No 669/2009 of 24 July 2009<sup>3</sup> (as amended by Commission Regulation (EU) No 212/2010 of 12 March 2010<sup>4</sup>, Commission Implementing Regulation (EU) No 323/2014 of 28 March 2014<sup>5</sup>, Commission Implementing Regulation (EU) No 718/2014 of 27 June 2014<sup>6</sup> and Commission Implementing Regulation (EU) 2016/443 of 23 March 2016) and Commission Regulation (EU) No 885/2014 of 13 August 2014<sup>7</sup>, Commission Implementing Regulation (EU) 2015/943 of 18 June 2015<sup>8</sup> and Commission Regulation (EU) 2016/166 of 8 February 2016;".
