EUROPEAN UNION (CEREAL SEED) (AMENDMENT) REGULATIONS 2016

I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2015/1955 of 29 October 2015¹, hereby make the following regulations:

1. These Regulations may be cited as the European Union (Cereal Seed) (Amendment) Regulations 2016.

2. The European Union (Cereal Seed) Regulations 2013 (S.I. No. 217 of 2013) are amended in Regulation 2(1) by substituting the definition of "Directive" for the following-
