SOCIAL WELFARE (CONSOLIDATED CLAIMS, PAYMENTS AND CONTROL) (AMENDMENT) (NO. 1) (ASSESSMENT OF MEANS) REGULATIONS 2018

I, REGINA DOHERTY, Minister for Employment Affairs and Social Protection, in exercise of the powers conferred on me by section 4 (amended by section 96 of the Ministers and Secretaries (Amendment) Act 2011 (No. 10 of 2011)) of the Social Welfare Consolidation Act 2005, and by sections 2(2)(c), 232 and 297 of, and Reference 19 in Table 2 to Schedule 3 to, the Social Welfare Consolidation Act 2005, with the consent of the Minister for Public Expenditure and Reform, hereby make the following Regulations:

Citation and construction

- 1. (1) These Regulations may be cited as the Social Welfare (Consolidated Claims, Payments and Control) (Amendment) (No. 1) (Assessment of Means) Regulations 2018.
- (2) These Regulations and the Social Welfare (Consolidated Claims, Payments and Control) Regulations 2007 to 2017 shall be construed together as one and may be cited together as the Social Welfare (Consolidated Claims, Payments and Control) Regulations 2007 to 2018.

Definition

2. In these Regulations "Regulations of 2014" means the Social Welfare (Consolidated Claims, Payments and Control) (Amendment) (No. 8) (Assessment of Means) Regulations 2014 (S.I. No. 595 of 2014).

Calculation of means

- 3. The Social Welfare (Consolidated Claims, Payments and Control) Regulations 2007 (S.I. No. 142 of 2007) are amended—
 - (a) in article 8(3) (amended by article 3 of the Regulations of 2014)—
 - (i) by the deletion of "or" after subparagraph (ba)(iii), and
 - (ii) by the insertion of the following paragraph after paragraph (ba):
 - "(bb) any *ex gratia* payments made under the Scheme of Compensation for Personal Injuries suffered at the Stardust, Artane on 14 February 1981,

or",

(b) in article 155 (amended by article 3 of the Regulations of 2014)—

- (i) by the deletion of "or" after subparagraph (ba)(iii), and
- (ii) by the insertion of the following paragraph after paragraph (ba):

or",

and

- (c) in article 174 (amended by article 3 of the Regulations of 2014)—
 - (i) by the deletion of "or" after subparagraph (fb)(iii), and
 - (ii) by the insertion of the following paragraph after paragraph (fb):
 - "(fc) any *ex gratia* payments made under the Scheme of Compensation for Personal Injuries suffered at the Stardust, Artane on 14 February 1981,

or".

EXPLANATORY NOTE

These Regulations provide that any income received by way of *ex gratia* payments awarded by the Stardust Victims' Compensation Tribunal will be disregarded in the assessment of means for the purposes of weekly social assistance payments, increases for qualified adults and Working Family Payment.
