# RULES OF THE SUPERIOR COURTS (APPEALS FROM THE CIRCUIT COURT) 2018

- 1. (1) These Rules, which may be cited as the Rules of the Superior Courts (Appeals from the Circuit Court) 2018, shall come into operation on the 31st day of October 2018.
- (2) These Rules shall be construed together with the Rules of the Superior Courts.
- (3) The Rules of the Superior Courts as amended by these Rules may be cited as the Rules of the Superior Courts 1986 to 2018.
  - 2. The Rules of the Superior Courts are amended:
- (i) by the substitution in rule 5 of Order 110 for "Such notice of appeal shall be in Form No. 3 in Appendix I" of "Such notice of appeal shall be in Form No. 1 in Appendix I with such modifications as may be necessary.", and
- (ii) by the substitution for Forms 1, 2 and 3 in Appendix I of the forms 1 and 2 as set out in the Schedule.
