ORDER 2019

An tSeirbhís Oideachais Leanúnaigh agus Scileanna, after making such inquiries as it thinks proper and consultation with organisations and associations appearing to it to be representative of substantial numbers of employers in the activities referred to in this Order and of substantial numbers of persons employed in such activities, in exercise of the powers conferred on it by section 23 of the Industrial Training Act 1967 (No. 5 of 1967) and by section 38 of the Further Education and Training Act 2013 (No. 25 of 2013) hereby makes the following Order:

1. This Order may be cited as the Industrial Training (Process Analytics Industry) Order 2019.

2. The following activities are hereby declared to be designated industrial activities for the purposes of the Industrial Training Act 1967 (No. 5 of 1967):

- (a) the monitoring and studying of business systems and processes and/or manufacturing systems and processes;
- (b) the performance of quantitative analysis of data and metrics associated with business systems and processes and/or manufacturing systems and processes; and
- (c) the design, testing, implementation and evaluation of business systems and processes and/or manufacturing systems and processes, and/or modifications thereof.
