VARIATION OF DAYS AND HOURS (NAAS) ORDER 2019.

The Courts Service, in exercise of the powers conferred on it by Section 26 of the Courts of Justice Act 1953 (No. 32 of 1953), as amended by Section 43 of the Courts (Supplemental Provisions) Act 1961 (No. 39 of 1961), Section 16 of the Courts Act 1971 (No. 36 of 1971) and Section 29 of the Courts Service Act 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. (a) This order may be cited as District Court Districts and Areas (Amendment) and Variation of Days and Hours (Naas) Order 2019.
- (b) This Order shall come into operation on 1st October 2019.

2. The First Schedule to the District Court (Areas) Order 1961 (S.I. No. 5 of 1961) is hereby amended by-
 - (a) The deletion at reference number 123 of the matter in columns (2), (3), (4) and (5)
 - (b) The substitution at reference number 125 for the matter in columns (4) and (5) of the following:

4. Business transacted in the District Court that is initiated and not completed before commencement of this order shall be continued and completed as if this Order had been in force at the time at which such business had been initiated.
