I, Seán Kyne, Minister of State at the Department of Culture, Heritage and the Gaeltacht, in exercise of the powers conferred on me by section 7(2) of the Gaeltacht Act 2012 (No. 34 of 2012) (as adapted by the Arts, Heritage, Regional, Rural and Gaeltacht Affairs (Alteration of Name of Department and Title of Minister) Order 2017 (S.I. No. 350 of 2017)) and the Culture, Heritage and the Gaeltacht (Delegation of Ministerial Functions) Order 2018 (S.I. No. 449 of 2018), hereby order as follows:
