#### EUROPEAN COMMUNITIES (INTRA-COMMUNITY TRANSFERS OF DEFENCE RELATED PRODUCTS) (AMENDMENT) REGULATIONS 2025

I, PETER BURKE, Minister for Enterprise, Trade and Employment, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Delegated Directive (EU) 2025/290 of 4 October 2024<sup>1</sup> amending Directive 2009/43/EC of the European Parliament and of the Council as regards the updating of the list of defence-related products in line with the updated Common Military List of the European Union of 19 February 2024<sup>1</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Intra-Community Transfers of Defence Related Products) (Amendment) Regulations 2025.

2. Regulation 2 of the European Communities (Intra-Community Transfers of Defence Related Products) Regulations 2011 (S.I. No. 346 of 2011) is amended, in paragraph (1), by the substitution of the following definition of 'Directive':

'Directive' means Directive 2009/43/EC of the European Parliament and of the Council of 6 May  $2009^2$  simplifying the terms and conditions of transfers of defence-related products within the Community as amended by –

- (a) Commission Directive 2010/80/EU of 22 November 2010<sup>3</sup> amending Directive 2009/43/EC of the European Parliament and of the Council as regards the list of defence-related products,
- (b) Commission Directive 2012/10/EU of 22 March 2012<sup>4</sup> amending Directive 2009/43/EC of the European Parliament and of the Council as regards the list of defence-related products,
- (c) Commission Directive 2012/47/EU of 14 December 2012<sup>5</sup> amending Directive 2009/43/EC of the European Parliament and of the Council as regards the list of defence-related products,

#### EXPLANATORY NOTE

# (This note is not part of the instrument and does not purport to be a legal interpretation.)

The purpose of the Intra Communities Transfer Directive (Directive 2009/43/EEC of the European Parliament and of the Council of 6 May 2009) is to simplify the rules and procedures applicable to the intra-Community transfer of defence related products.

The list of products covered by Directive 2009/43/EEC is the "EU Common Military List". As the common military list is updated regularly, the Directive is also updated with an amended list. These Regulations implement and give effect to Commission Delegated Directive (EU) 2025/290 of 4 October 2024 to reflect the amendments made in the EU Common Military List.
